I have read this form and agree to all information contained herein.

Earth Camp is a virtual program in the summer of 2020. Past owners Bev and Mark Buswell have transferred ownership for the summer to Alyssa Buswell and are not supervising and therefore are not liable for Earth Camp during this summer.

I hereby approve of my son/daughter/self (child, parent, &/or volunteer) participating in the activities he/she/I will be participating in. I understand that it's a parent's responsibility to supervise all activities my child participates in with Virtual Earth Camp. "Virtual" refers to any activity, instruction, suggestion, idea, connection, etc. that is not done in person, including but not limited to online conferencing such as Zoom, video or audio phone calls such as facetime, and written instruction such as email, etc. Instructions for any such activities are just ideas and the parent must decide whether to allow the child to do it and if so, how, and how to supervise. I will use good judgement in deciding if my son/daughter/self is capable and safe to participate in of the activities. I understand that Earth Camp 2020 is not subject to licensing regulation partly due to its virtual nature.

Unless I have otherwise noted on this form, I give permission for: 1) My contact info to be given to parents in the same program. I agree that if I should receive contact information for other families, to only use this information for the purpose of connection and not for commercial purposes. 2) Photographs, video, audio, statements, and images that include my child/self to be used (in fliers, brochures, website, etc.). Covid and other risk management arising from any physical contact arising out of such exchange of contact info will be solely the responsibility of parents.

I understand that many activities, such as those taught by a nature-based school or camp, naturally contain risk. While Earth Camp will take due precaution as to the objective hazards and inherent risks of each program activity, natural and unforeseen events can occur. I understand it is up to my careful discretion as to whether or not to allow my child to use knives or other dangerous activities and that I will supervise ALL activities. **I HAVE READ AND UNDERSTAND AND AGREE to all information in this agreement, as well as the information given to parent by owner or on the Earth Camp 2020 web page.**

I knowingly and freely assume all such risks, both known and unknown, and assume full responsibility for my child's / own participation in activities of wildflowers. I, for myself and on behalf of my children and their relatives, my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless earth camp, it's owners, affiliates, and their owners, contractors, officers, board members, employees, volunteers, representatives, agents, advertisers, officials, sponsors, owners and lessors of any premises used, and anyone connected to the conduct of their affairs (releasees), from any and all claims, demands, losses, and liability arising out of or related to any injury (including but not limited to physical and emotional), disability or death my child/self may suffer, or loss or damage to property during any and all activities of earth camp or its owners, et al. In case of dispute, i consent to mediation as a condition precedent to the initiation of any adjudicative action or proceeding, including arbitration.
